<u>Payment of Bills:</u> *Mr. Blue moved to authorize payments totaling \$293,648.06, motion seconded by Mr. Wiech. Roll call: Yeas (6).* There were 3 payroll in the month of March.

FISCAL OFFICER'S REPORT: Income Tax and Financials – Report is included in the packet. Income tax is up approximately 2%. Water and sewer revenue has been declining, discussed the aging population and the discount that they receive. Expenses are down and revenue is up. Withholding tax is strong which indicted growth in employment.

**ECON DEVELOPMENT:** Report is included in the packet. Still working with the proposed Giant Eagle plaza tenant. Still in contact with NEO. Attended the commissioner meeting. There have been two revolving loan applications and one has been approved and one more application is expected in the next month or so.

**ZONING REPORT:** Report is included in the packet. Mr. Bellas stated that the department issued 4 permits for the month of March. Working on several complaints with the prosecutor's office.

<u>DIRECTOR OF STREETS & UTILITIES REPORT</u> – Report is included in the packet. Chief Tucholski stated that the department has used about 500 ton of salt to date; which is low. The tractors are prepped for mowing. Park bathrooms are being opened for the season. Pump maintenance and repairs. Discussion regarding the proposed repair work on north 608. Discussion regarding the Water main break and transferring the other few businesses and residents that are still on that line.

<u>POLICE REPORT</u> – Report is included in the packet. Chief Tucholski gave the statistics for the month of March. 468 calls for service; up a little bit from last year. Discussion regarding the Sheriff's Department investigation and warrant served at 15900 Grove Street.

<u>PARKS & RECREATION REPORT</u> – Report is included in the packet. The Kitchen Kids program is currently underway. Received quotes for the dog park fencing. Soccer and Softball practices are underway and games will start soon. Ms. Warren thanked all her volunteer for all the help with the Egg Hunts.

**FIRE DEPARTMENT REPORT** - Report is included in the packet. Chief Reed gave the statistics for the fire department; 195 runs year to date. Discussion regarding what a "Hazardous Condition" entitles. Believes that was the night of the high winds and probably was wires down.

<u>AMBULANCE REPORT</u> – Report is included in the packet. Mr. Koepf gave the statistics for the month of March. Average response time is 4.6 minutes.
