OLD BUSINESS

1. **Village Finances – Discussion:** Mr. Giardina stated water, sewer, and income tax are down compared to previous years but Mr. Giardina stated it will break even at the end of the year. Mr. Giardina stated all accounts are still in the positive. There have been a lot of expenses like the water line project but there have also been a lot of receipts. Mr. Giardina stated the withholdings are down compared to the year before but overall the withholdings are still strong. Mr. Giardina stated the wages are up due to more employees. Mr. Giardina stated it has been a positive year and a lot of expenses were paid off. Mr. Giardina stated a refund of \$250,000 will go out in the mail next month due to overpayment in estimates for a company. The estimate payments go back to 2021 and it was determined it is valid. Mr. Giardina stated the good thing is while the village had the \$250,000 in the bank account interest of 6% was able to be collected on the money.
