- 1) Continued Public Hearing for Sherpa Development Corporation, LLC Hartville Hardware 15264 -15310 Kinsman Road, Proposed new construction on PPN's (annexation / consolidation pending,): 18-084600, a 1.25 acre parcel, 18-084900, a 24.09 Acre parcel and 19-072866, a 1.13 acre parcel. Request is for a 56% lot coverage, where 40% lot coverage is permitted in a GC- General Commercial zoning district per Section 1155.01 Schedule of Dimension and Area Requirement by District.
  - 81,000 Sq. Ft. main structure, with 60,000 retail merchandise display.
  - A 36,120 Sq. Ft. indoor lumber yard.
  - Four (4) storage structures totaling 41,248.75 Sq. Ft.
  - 280 spaces for parking, four loading docks and trash compactor bay.
  - Entrances off Tare Creek parkway as well as Kinsman road.
  - Storm water retention basin.

Project is currently under review by Geauga Soil and Water Conservation District as well as the Village of Middlefield Engineer.
